CALL FOR ABSTRACTS

Secondly, the conference aims to identify the key determinants of Ukraine's financial security and develop recommendations to enhance the resilience of the national economy. Lastly, it aims to launch the "Scientific Student Dialogue" program as a platform for regular interaction and joint research of young academics from different countries in international finance.

REQUIREMENTS FOR FORMATTING AND SUBMISSION OF ABSTRACTS

- papers that have not been published are accepted for publication;
- the number of authors per paper should not exceed three;
- abstracts should be submitted electronically in .doc or .docx format;
- abstracts should cover 2 to 5 pages, A4 format;
- font: Times New Roman; size 14; line spacing 1.5; margins 2 cm; paragraph indentation 1.25 cm;
- each table, illustration, diagram, or graph must have a heading and be numbered;
- the list of references should contain only sources cited in the text; cited literary sources should be numbered according to the order of reference to them in the text; format: APA;
- pages should not be numbered;
- the use of illustrative material in the abstracts should be kept to a minimum;
- the name of the abstract should contain the name of the conference participant. For example: "Kolomiiets_Abstracts".

STRUCTURE of abstracts:

- thematic area of the conference (bold font);
- surname and initials of the author(s) (bold font);
- university degrees, academic titles, position;
- name of the organization where the author works or studies;
- city, country;
- ORCID;
- Email addresses of all authors:
- title of the abstracts (bold font, capital letters);
- main text;
- references (bold font).

Abstracts that do not meet the specified formatting requirements will not be considered.
